This agreement form and final catering order form must be completed and submitted no later than seven (7) days prior to the event date specified in this document. If these forms are not submitted by this deadline, we reserve the right to decline the catering request.

1. PARTIES

The parties to this Catering Agreement (the "Agreement") are:

Craft Putt LLC (collectively, referred to as "CRAFT PUTT") and

Guest (collectively, referred to as "GUEST", whether one or more individuals as outlined by the information provided on this form).

2. AGREEMENT

This Agreement is entered into on the day signed by the GUEST.

3. TERM OF THE AGREEMENT

This Agreement is for CRAFT PUTT to provide in-house food catering to the GUEST at the Craft Putt facility located at 11440 W 135th St, Overland Park, KS 66221 on the date specified on page 1 of this document.

4. CATERING FEES

GUEST agrees to pay a catering fee (the "Catering Fees") to CRAFT PUTT during the term of this Agreement based on the GUEST COUNT and MENU SELECTIONS provided in this document.

5. MENU SELECTION

GUEST must have menu selected seven (7) days prior to the event date. CRAFT PUTT may choose to accommodate off-menu selections, and if the GUEST elects to deviate from the pre-set menu, a surcharge of a minimum 10% will be adjusted to the per guest price.

6. GUEST COUNT

GUEST must provide guest number confirmation seven (7) days prior to event date. Once the event date is within seven (7) calendar days, CRAFT PUTT will consider this number the guaranteed amount, and it will not be subject to reduction. If GUEST requests the guest count to increase within seven (7) calendar days of the event, CRAFT PUTT is not obligated to honor this increase.

7. CATERING DEPOSIT

Upon the execution of this Agreement, the GUEST shall deposit the sum of \$100.00 or 10% of the Catering Fees, whichever is greater, to secure this Agreement. This deposit is non-refundable and will be used as a credit towards the total Catering Fees.

8. FOOD POLICY

Once food is served it may only remain out for a maximum of two (2) hours as per food and safety requirements from the Kansas State Department of Agriculture. Taking catering food "TO-GO" is NOT permitted. The catering set up will be broken down and cleared 20 mins before the end of your reservation time to ensure the space can be cleaned thoroughly before the next guests use.

9. CANCELLATIONS

For all cancellations of events, the deposit is forfeited.

10. FINAL PAYMENT

Final payment of the Catering Fees must be made 48 hours prior to the event. If the final payment has not been completed at this time, CRAFT PUTT reserves the right to terminate this Agreement where no deposits are returned to the GUEST.

11. SALES TAX

A 6.5% Kansas sales tax, 1.12% Overland Park sales tax, and 1.48% Johnson county sales tax will be added to the Catering Fees in this Agreement.

12. GRATUITY

All food and beverage purchased by this group on the day of the event will have a 20% gratuity added. This does NOT include any food purchased in this Catering Agreement.

CONTD.

13. NON-PERFORMANCE CLAUSE

CRAFT PUTT shall not be liable for non-performance of this contract when such nonperformance is attributable to labor troubles, disputes or strikes, accidents, government (Federal, State and Municipal) regulations of, or restrictions upon travel or transportation, non-availability of food, beverage or supplies, riots, national emergencies, acts of God and other causes whether enumerated herein or not, which are beyond the reasonable control of CRAFT PUTT preventing or interfering with the restaurants performance of its obligations under this contract.

This contract is made in the State of Kansas and shall be construed and enforced in accordance with the laws of such State. This Agreement constitutes the entire agreement between parties and may not be modified or amended except by an instrument in writing signed by both the GUEST and CRAFT PUTT.
